Monday April 25, 2011

A meeting of the West Caln Township Board of Supervisors was held on Monday April 25, 2011 at 7:00 P.M. in the Township Administration Building. Present were Supervisors Martz, Pfitzenmeyer and Price, Treasurer Johnson, Road Forman Touchton, Solicitor Moskowitz, Ass't Manager Vaughn and Manager-Secretary Dunlap. There were 7 citizens in attendance.

Chairman Pfitzenmeyer opened the meeting and lead in the salute to the flag. The following business was then conducted.

1. Citizen's Comments. None.
2. Zoning Ordinance Amendment. Matter will be scheduled for the May 9, 2011 meeting.
3. Road Material and Equipment Bid Opening.


Mr. Dunlap reported that the Bid Notice did not get published as requested by the Daily Local News. The notice will be published and the bid opening will be moved to May 23, 2011.

4. Mr. Pfitzenmeyer moved to appoint John Schrack of Wagontown as an Alternate Member of the Zoning Hearing Board. Second, Mr. Martz. Questions, none. Vote was 3-0 in favor of the motion.
5. Mr. Pfitzenmeyer moved to grant permission to hold a Tennis Camp at the Court in Layton Park. The fee for the Camp will be \$100.00 per week and the event will be held June 21 through July 30<sup>th</sup>. Second, Mr. Martz. Questions, none. Vote 3-0 in favor of the motion.
6. Mr. Price moved to appoint Kevin Valenta of Lakewood Dr. to the Planning Commission to fill out the term of Gail Pippin. Second, Mr. Pfitzenmeyer. Questions, none. Vote 3-0 in favor of the motion.
7. Mr. Moskowitz reported he contacted Attorney Allen Toadvine concerning the Calnshire matters, and the Attorney representing John Davidson concerning the property on Airport Rd. He has not received a response from either. Mr. Moskowitz further stated that he is working with Mr. Vaughn on a Property Maintenance Complaint against Mr. Davidson. A memo regarding running water on to public roads was discussed. Mr. Moskowitz feels that if the situation is deemed a nuisance, action can be taken against the offender.

With no further business at hand, adjournment was at 7:15 P.M.
